



# Truck and Equipment Crossing or Entrance



**NOTES:**

- ON NON-DIVIDED HIGHWAYS, PROVIDE SIGNS ONLY ON THE RIGHT SIDE.
- APPLICABLE ONLY WHEN LICENSED VEHICLES ARE ENTERING OR CROSSING TRAFFIC WITHOUT THE AID OF A FLAGGER.
- SIGN 2 NOT NEEDED IF CROSSING OR ENTRANCE IS LOCATED WITHIN THE LIMITS OF AN ACTIVITY AREA WHERE ANOTHER SIGN 2 IS ALREADY USED.

Truck Crossing or Entrance




**NOTES:**

- SIGN 2 NOT NEEDED IF CROSSING OR ENTRANCE IS LOCATED WITHIN THE LIMITS OF AN ACTIVITY AREA WHERE ANOTHER SIGN 2 IS ALREADY USED.
- SIGNS 3, 4, 25 AND 54 NOT NEEDED IF CROSSING OR ENTRANCE IS LOCATED WITHIN THE LIMITS OF AN ACTIVITY AREA WHERE AN APPROPRIATE SPEED LIMIT, EITHER NORMAL OR REDUCED, IS ESTABLISHED.

**NOTES:**


SIGN ② NOT NEEDED IF ENTRANCE IS LOCATED WITHIN THE LIMITS OF AN ACTIVITY AREA WHERE ANOTHER SIGN ② IS ALREADY USED.

SIGNS ③, ④, ②⑤ AND ⑤④ NOT NEEDED IF CROSSING OR ENTRANCE IS LOCATED WITHIN THE LIMITS OF AN ACTIVITY AREA WHERE AN APPROPRIATE SPEED LIMIT, EITHER NORMAL OR REDUCED, IS ESTABLISHED.


